Review/Approve changes to Rural County Transportation Program (RCTP) ranking process

Fox updated the board on how the ranking process is currently. Fox stated there is an is an issue they have been made aware of with the local match points. Currently the projects get ranked out of 100 and local matches are 20 of those 100 points. So, cities have to have a 20% local match for their projects to rank well within the ranking process and if they have more than 20%, they receive more points. The problem with this is when cities are submitting their applications for RCTP projects they are committing to the local match needed to rank well, but when it comes to implementing the project, the cities do not have the local match to put towards the project and request extensions on the project. The problem is when you the money needs to be spent within the fiscal year and if they request an extension then it's up to the county to float the money to these cities so they can complete their project and that is becoming an issue with the counties, as this is becomes a budgeting problem for the counties. So, the county is asking if the RPA can look at the local match piece of the ranking process to address this issue.

Discussion followed.

Kinney proposed that the extra points for more than 20% match is removed from the process and distributed to other criteria, but the 20% match requirement stays.

Discussion followed.

Ravada suggested staff update the ranking process and also take the process to the clerks meetings to get input and bring it back to the Board at the September meeting.

Motion by Koopman, second by Weber to recommend to the RPA 8 Policy Board to table the changes to Rural County Transportation Program (RCTP) ranking process until the September meeting. The motion passed unanimously.

Motion by Kida, second by Gaul to table the changes to Rural County Transportation Program (RCTP) ranking process until the September meeting. The motion passed unanimously.

Discuss changes to Small City Funding

Ravada reminded the board that in 2023 the board decided to not reimburse the counties and give the money to the small city fund that was not receiving funds due to the new transportation bill. Ravada stated staff received a request to see if counties could get reimbursed for the loss in FY24 and FY25. Ravada stated it would be approximately \$600,000 to reimburse counties. Ravada stated if counties are reimbursed it will affect the small city pot of money.

Discussion followed.

The board agreed the members don't want to take away from the small city funds because that program is important and needed.

Michel commented on the discussion of small cities funds, and he appreciates the discussion and wanted to let the board know there are projects coming down and small cities are grateful for that money being available.
